

PRODUCT SPECIFICATION

This certificate covers the PB inner pipe of the Viega Smartloop piping system for the transport of cold en heated drinking water.

APPROVAL

The products are approved on the basis of the requirements set in the "Regeling materialen en chemicaliën drink- en warm tapwatervoorziening" (Regulation materials and chemicals for drinking water and warm tap water supply; published in the Government Gazette).

ATA-CRITERIA

The ATA-product certification is based on two main criteria. It should permanently comply with the:

- product recipe approved during the assessment procedure. This recipe is not to be changed without prior approval by Kiwa following the Kiwa-ATA-approval procedure.
- specific product requirements (see "ATA-PRODUCT REQUIREMENTS").

ATA- PRODUCT REQUIREMENTS

For this product is relevant the positive list mentioned in the "Regeling materialen en chemicaliën drink- en warm tapwatervoorziening" (published in the Government Gazette).

After 30 days the maximum tolerable concentration in the drinking water (MTC_{drinking water}) of the following substances or parameters may not exceed the numerical values mentioned behind.

- TOC 2 mg/l;
- Odour < 16;
- Flavour < 16;
- Colour 10 mg/l Pt.

The remaining valid MTC's are, with respect to confidentiality, laid down in the non public appendix with certification agreement K82663.
